



## **2008 ATA GREAT GIVEAWAY SWEEPSTAKES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW. SWEEPSTAKES IS SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS.**

**THE 2008 ATA GREAT GIVEAWAY SWEEPSTAKES IS OPEN TO ALL ATTENDEES OF THE GREAT GIVEAWAY EVENT. ENTRY INTO THE TRADE SHOW OR EVENT IS NOT REQUIRED TO ENTER THE SWEEPSTAKES.**

Sweepstakes prizes subject to the restrictions identified in these *OFFICIAL RULES* and other reasonable terms established by Sweepstakes Organizer.

Participation in the sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of all *OFFICIAL RULES*. Sweepstakes participants should carefully review *OFFICIAL RULES* before entering the Sweepstakes. **1. Eligibility: THE 2008 ATA GREAT GIVEAWAY SWEEPSTAKES IS OPEN TO ALL ATTENDEES OF THE GREAT GIVEAWAY EVENT. The following definitions apply:**

Directors, officers, employees, consultants, agents and volunteers of Organizer, or of any respective affiliates, subsidiaries of Organizer, or immediate family members of those employed or whose services are retained by Organizer, as well as persons living in their same household, are not eligible to participate in the Sweepstakes.

**2. How to Enter:** To enter the ATA Great Giveaway Sweepstakes, contestants must submit their entry forms to the Registration Area of the ATA Trade Show in the Indianapolis Convention Center PRIOR to the opening of the ATA Great Giveaway event on Friday, Jan. 11, 2008. A complimentary Sweepstakes entry form may be requested either at the Registration area during the ATA Trade Show (must be picked up before 6:00 pm on Jan. 11<sup>th</sup>) or by mailing a legibly written self-addressed, stamped envelope with sufficient postage and a return address (must include first and last name, street address, city, state and zip code) to: 2008 ATA Great Giveaway Sweepstakes, 860 E. 4500 S., Ste. 310, Salt Lake City, UT 84107. Mailed requests must be received on or before Dec. 28, 2007. Limit one entry per request.

### **3. Prizes:**

**4. Odds of Winning:** The odds of winning any of the prizes in the Sweepstakes are approximately one in 5,000.

**5. Winner Selection:** Winning entries will be selected from all eligible entries at a random drawing by Organizer, whose decision is final and binding in all matters relating to this Sweepstakes. The drawing will be held during the ATA Great Giveaway event the evening of January 11, 2008. Winners' names will be posted on screens inside the Sagamore Ballroom and in the halls outside of the Sagamore Ballroom.

Prizes not claimed at the designated areas in the Sagamore Ballroom within five minutes of being announced will be forfeited and a winner will be redrawn.

Prizes will be awarded to the individual who, as authorized, is in possession of the winning entry form. Winners must claim and redeem their prizes in person. The determination of the judges as to the authorization will be final. Sweepstakes entries that contain printing or other typographical errors, or are issued erroneously, altered, illegible, mutilated, separated, counterfeit or not obtained through legitimate sources and/or channels are automatically void. Any dispute arising from this Sweepstakes will be determined in accordance with the laws of the State of Virginia, without reference to Virginia's conflict of laws principles, and the participants and winners hereby consent to the personal jurisdiction of the State and Federal Courts of Virginia and do hereby specifically waive any personal jurisdiction defense that they may have to the exclusive jurisdiction of the State and Federal Courts of Virginia over all such persons and such disputes relating in any way to this Sweepstakes.
